## CHILDREN POLICIES

**IMPORTANT PLEASE READ**

- A CHILDREN'S REGISTRATION FORM IS REQUIRED WHEN SIGNING UP FOR THE CHILDREN CLASS SCHEDULE. PLEASE NOTE ALL CHILDREN AND TEENS UNDER THE AGE OF 18 MUST HAVE A PARENTAL SIGNATURE OR A LEGAL GUARDIAN SIGNATURE ON FILE BEFORE ANY PARTICIPATION IN CLASS IS ALLOWED.
- **ALL CLASSES MUST BE PRE-PAID** BEFORE PARTICIPATING.
- CHILDREN'S TUITION IS DUE BY 8TH OF EACH MONTH. **A \$10.00 LATE FEE** WILL APPLY AFTER THE 8TH OF THE MONTH \* **NO EXCEPTIONS** \*
- WE ALLOW FOR MAKE-UP CLASSES AS A PRIVILEGE, NOT AS AN OBLIGATION.
- CHILDREN'S CLASSES ARE CHARGED BY THE MONTH AND BASED ON A YEARLY TUITION – MAKE-UPS ARE ALLOWED AND MUST BE TAKEN UPON AVAILABILITY OF A CLASS AND CANNOT BE PRO-RATED INTO THE NEXT MONTH.
- NOTIFY THE FRONT DESK, WHEN MAKING UP A CLASS FOR AVAILABILITY OF CLASSES
- MAKE-UP CLASSES THAT HAVE NOT BEEN APPROVED OR MARKED AS A MAKE-UP WILL BE BILLED AS A REGULAR CLASS.
- SPECIAL TUITION PACKAGES RECEIVE NO ANNUAL PAYMENT DISCOUNT.

- A COSTUME DEPOSIT IS DUE BY DEC 15TH 2006. ONE COSTUME DEPOSIT OF \$30 PER CLASS OR PRIVATE LESSON IS REQUIRED.
- ANY UNPAID BALANCES AFTER JUNE 14TH 2007 WILL RESULT IN THE STUDENT BEING DENIED PARTICIPATION IN THE RECITAL. NO REFUNDS WILL BE MADE FOR COSTUMES OR TICKETS PURCHASED.
- ATTENDANCE AT REHEARSAL IS MANDATORY. STUDENTS WILL BE SCHEDULED TO REHEARSE BETWEEN 9AM AND 4PM. STUDENTS WHO MISS REHEARSAL WILL NOT BE ALLOWED TO PARTICIPATE IN THE RECITAL.
- TICKETS MUST BE PURCHASED FOR THE RECITAL BY EVERYONE OTHER THAN PARTICIPATING STUDENTS. TICKET PRICE IS \$12.00
- **BE ON TIME FOR SCHEDULED CLASSES** – STUDENTS **10 MINUTES LATE** NEED THE INSTRUCTOR'S PERMISSION TO ENTER CLASS (STANDARD CLASS ETIQUETTE)
- THE TEACHER IS ONLY REQUIRED TO WAIT 10 MINUTES – IF THE MINIMUM REQUIRED STUDENTS ARE NOT PRESENT CLASS WILL BE CANCELLED
- CHILDREN'S CLASSES WILL BE CANCELLED UNLESS THERE IS A **MINIMUM OF 1 STUDENT**.
